

PRE-QUALIFICATION NOTICE

EPC WORKS FOR WHITE OIL PIPELINE MOGAS PROJECT (WOPMP)

Pak-Arab Pipeline Company Limited (PAPCO), a subsidiary of Pak-Arab Refinery Limited, owns and operates a cross country pipeline of about 786 km in Pakistan for the transportation of diesel. The Company plans to convert this pipeline to multi-product use by transporting motor gasoline (MOGAS) also. The White Oil Pipeline Mogas Project (WOPMP) involves tanker unloading pipeline, storage tanks, gantries and Transmix Processing Facility etc. including associated civil, mechanical, electrical, instrumentation / control works.

Applications for Pre-qualification are invited from national and international companies for "White Oil Pipeline MOGAS Project comprising of Construction of storage tanks, Gantries, Transmix processing facility etc". Companies which have a proven record of executing similar projects specific to Oil Pipelines, Large Storage Terminals with Gantries and Petroleum refining facilities shall be considered for the pre-qualification. Only those companies which are pre-qualified under this notice shall be invited for competitive bidding for undertaking the EPC works on total responsibility basis.

Companies having required financial resources, equipment, manpower, and relevant experience may submit written request with a brief company profile, copy of NTN certificate (for local organizations) for obtaining the Prequalification document containing details of the project and instructions for submission of application for prequalification. Local agents/representatives of foreign companies and other such intermediaries shall not be issued prequalification documents unless a written authorization specific to this project on Company's letter head is submitted from the Principal Company along with a copy of NTN certificate of the local company.

Pre-qualification document may be obtained by mail / courier or by hand from the following office between **0900 hrs to 1230 hours** and **1400 hours to 1600 hours** from Monday through Friday from **17 Sep, 2015 to 8 Oct, 2015**.
